#### Introduction

## **Policy Scope**

#### **Roles and Responsibilities**

- The **Sustainable Development Committee (SDC)**, under the delegation of the Board of Directors, has the role to endorse and oversee this Policy to ensure its effective implementation.
- **The Management** has the role to set strategic directions, communicate this policy to all stakeholders, provide necessary resources and supports to ensure the effective implementation of this policy, as well as monitor the environmental performance for further improvement.
- The Environmental Committee (EC) assesses the potential impact of the activities throughout the life cycle and determines control measures or mitigations to reduce the impact of the activities. The EC is responsible for aligning working procedures with the strategic directions and the environmental policy, reviewing the environmental performance within its own scope of work, and reporting the progress to the management.
- All employees, suppliers, contractors, business partners, and joint ventures shall be understood, aware and comply with this policy.

5. **To continuously improve the environmental performance** in our operation, products and services, through regular monitoring, measuring, and reporting the environmental performance on an annual basis, including but not limited to energy consumption, water use, greenhouse gas emission, and waste management.

6. **To promote environmental best practices and mandatory standards** in our business value chain through the procurement process by selecting vendors, suppliers, and contractors according to their environmental performance and compliance with our environmental policy.

7. **To collaborate and work with partners** in promoting the circular economy and improving the operational eco-efficiency.

8. To raise awareness and provide appropriate training for employees, suppliers, contractors, and other related stakeholders to help them understand and implement applicable environmental regulations, policies, and best practices effectively.

9. To perform proper environmental due diligence with all key environmental risks in the merger or acquisition.

10. To communicate transparently and regularly with our stakeholders, providing information regarding environmental performance on the annual basis.

#### **Monitoring and Review**

This policy will be monitored and reviewed on an annual basis. This is to ensure that it is still valid and in line with the current local and global context by complying with environmental laws & regulations as well as responding to potential risks and opportunities.
