Pre-register is required

Limit 200 seats

How we conduct meeting

- Each attendee is provided with designated seat and is not allowed to move to another seat throughout the duration of the meeting.



COVID-19 screening

 - Any individual showing symptoms of fever or the body temperature over 37.5 degrees celcius
- Any individual showing symptoms of cough and/or sore throat

- Any individual who has been in crowed place or engage with tourists in the period of 14 days prior to the meeting.
